204 N 15 St Kansas City Kansas offers computer network and internet access to household members while providing guest internet access to individuals not part of the household.

Usage Rules

We have implemented rules to govern computer network usage and internet access at our location. These rules ensure fair and responsible usage by all household members and guests.

Acceptable Usage Guidelines

Users, both household members and non-household members, are expected to adhere to the guidelines outlined in the Acceptable Usage Guidelines for respectful and appropriate usage.

Additional Rules

- Users are prohibited from disabling or attempting to disable internet filtering and/or software.
- Usage of illegal software without proper licenses or access to illegal sites is strictly forbidden.
- Unauthorized access, including hacking, is not allowed.
- Users must not share their passwords or share the passwords of others.
- Any misuse or breaches of network security must be promptly reported by users.
- Users are not permitted to access, delete, copy, modify, or forge other users' emails, files, or information data.
- Disclosure of sensitive information is prohibited.
- Accessing or allowing access to pornography is strictly prohibited.
- All users are expected to utilize the network in support of legal activities.

Prohibitions

We reserve the right to determine what is appropriate and what is not on our network. The following actions are prohibited:

- Disrupting copyrighted materials to or from any Garcia Network without permission from the owner of the copyright.
- Using the network for advertising or solicitation.
- Creating, viewing, or possessing defamatory, obscene, profane, sexually oriented, threatening, harassing, or other materials prohibited by state, local, and federal laws.
- Using the network for illegal acts.

Monitoring

We reserve the right to monitor, without notice, usage of the computer network and internet access, including emails, sites, and any information obtained. Any information gathered will be the property of 204 N 15 St KCK 66102. No user has expectations of privacy when using the computer network and/or internet access.

Internet Safety

To ensure internet safety, the following categories are blocked:

- Child pornography
- Obscenity materials or other materials harmful to minors
- Chatrooms
- VPNs (Virtual Private Networks)
- Encrypted DNS
- Proxies
- Dating Sites
- Whitepages (People Finders)
- TOR
- Prank Sites

We cannot guarantee the filtering is 100% effective. Any user encountering a blocked site must report it to a System Admin. We reserve the right to prohibit access to anyone on the computer network and internet access if it is deemed inappropriate.

Cyberbullying is strictly prohibited. Cyberbullying includes but is not limited to, harassing, teasing, intimidating, threatening, or otherwise causing distress to others via electronic means.

Violations of these rules may result in the cancellation or restriction of service. Misuse can lead to legal action; law enforcement may be notified if misuse involves illegal activities.
